



Directive of the ASOSU President, № 2021-001

Subject: Rescinding a former executive action and establishing a new iteration of the ASOSU Student Advisory Board

As President of the Associated Students of Oregon State University, subject to the limitations and authority vested by the ASOSU Constitution, I issue the following directive for the administration of the executive branch, effective immediately upon signing:

The May 31, 2017 order of the then-President of the ASOSU (attached), establishing an ASOSU Student Advisory Board, is hereby rescinded.

In its place, I hereby establish a replacement directive to provide the following criteria for an ASOSU Student Advisory Board (SAB):

1. The SAB shall comprise the following membership:
 - a. Voting Members:
 - i. Two members-at-large from the student body;
 - ii. Two current representatives of the ASOSU student government;
 - iii. Two current student employees of the ASOSU Office of Advocacy;
 - iv. Two current student employees of ASOSU SafeRide;
 - v. The Diversity and Inclusion Director, or equivalent, of the ASOSU Executive Branch who shall serve in an ex officio capacity on the committee;
 - b. Non-voting members:
 - i. Two faculty/staff members;
 - ii. Any other designees of the below-cited bylaws;

Members serving in the ASOSU Congress may, subject to the limitations of the bylaws, be appointed and confirmed to fill the ASOSU student government membership seats on the ASOSU SAB, but are to recognize the conflicts of interest of voting on the proposed ASOSU budget within the ASOSU Congress during the SFC proceedings.

In recognition of any inconsistencies preexisting between the aforementioned rescinded order and the bylaws of the Advisory Board which presented its advice for ASOSU’s prospective budget in the most recent budget cycle, this directive appoints all members who were advising in this capacity immediately prior to the enactment of this directive, who I will notify in writing at the time of signing.

Furthermore, all provisions of the attached bylaws not conflicting with this directive are hereby instituted for the board. The SAB, with preemption in all cases given to the provisions of this and subsequent directives, is permitted to establish changes to its bylaws in accordance with these requirements.

Executive Order

Establishment of the ASOSU Student Advisory Board

By the authority vested in me as President by the Constitution and Statutes of the Associated Students of Oregon State University, I hereby order the establishment of an ASOSU Student Advisory Board.

The ASOSU Student Advisory Board will mirror other Student Advisory Boards within the Student Fee landscape and will be responsible for crafting, creating, assessing, and ultimately proposing the ASOSU budget to the Student Fee Committee.

The ASOSU Student Advisory Board will be composed of the following folks: one (1) student from the ASOSU Office of Advocacy, one (1) student from SafeRide, one (1) staff or student member from the ASOSU Student Legal Services, one (1) staff or student from the Oregon Student Association, one (1) Representative, one (1) Senator, three (3) at-large students, the ASOSU Speaker of the House, the ASOSU Vice President, and the ASOSU President. The Board will also include two voting faculty members and ex officio representation from each unit represented under the ASOSU budget.

If additional services or programs are created or added to the ASOSU budget, one student will be added to this Student Advisory Board to ensure adequate student voice in the process.
