**i. Review Senator draft resolutions written thus far**

**1. [Senator Nyarko](#)**

- a. It puts pressure on departments to follow how Student Affairs raised student wages.
- b. The sooner we get a resolution signed and enacted, the better because it gives us more time to reach out to campus employers and departments.

- c. The current campus minimum (\$14.20) is based on UHR minimum without regard to actual cost of living for students; could consider raising to \$15, like was requested in the past.
- d. Rather than a set dollar amount, should we base wages on a dynamic amount/model for increasing it each year?
  - i. If we don't have a set number, how do we track the progress/how do we know we have met our goal?
  - ii. Neither side of the argument can agree on a set number, so it may not be as productive.
  - iii. Departments may not appreciate a set number
- e. Who will negotiate with departments?
- f. We could ask the university to create a task force about this issue.
  - i. Forces them to continually evaluate this and work on it rather than put the burden on student government.

- b. Intent is to show solidarity with student workers who do not make as much as Senators after the ongoing debates around student wages.
